





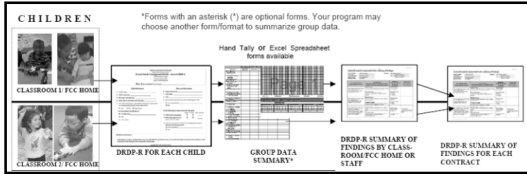

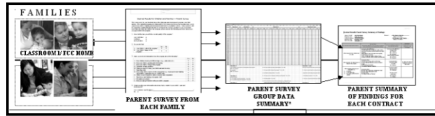

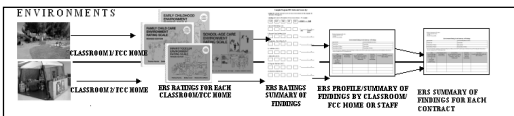
DR System Process: Families
